Carbon Reduction Initiatives

RVL Group is implementing several key initiatives to reduce our carbon footprint:

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

- Committing to neutralising RVL's own emissions from training and positioning flights
- Implementing a new flight planning tool which will optimise fuel efficiency
- A rolling programme of upgrading existing lighting to be more energy efficient
- The introduction of a salary sacrifice scheme, enabling employees to lease hybrid and electric vehicles via a company scheme, along with installation of EV charging points at the business premises
- Implementing a digitisation strategy which will reduce the need for printed documentation

While we have a good understanding of our scope one and two emissions, we are less confident with scope three and will be actively addressing that situation over the coming year.

We project that carbon emissions will decrease over the next five years to 10% tCO2e by 2028. By 2050, we aim to achieve Net Zero.
